Public Engagement with Historical Record (NARA)

Scope:

For the Public Engagement with Historical Records announcement to encourage public engagement with historical records.

Deadline:

November 2, 2023.

Funds:

\$600,000 total for up to five awards ranging from \$50,000 to \$150,000.

Areas:

The program is designed to form collaborations among archivists, educators, historians (including documentary editors), and people working in community-based archives to involve the public in discovering and using historical records. NARA is looking for collaborative projects that create models, tools, and technologies that other institutions can freely adopt to serve other communities.

Archival Projects (NARA)

Scope:

Seeks applications for the Archival Projects announcement to significantly improve online public discovery and use of historical records collections.

Deadline:

November 2, 2023.

Funds:

\$1.2 million total for up to 12 awards of up to \$150,000.

Areas:

The successful application will: demonstrate the value of the collections to the understanding of U.S. democracy, history, and culture; outline a work plan that uses archival best practices; be appropriately staffed with archivists; propose a cost-effective budget; and outline activities that connect researchers to the project's collections, as well as the rest of the repository's holdings.

Humanities Connections (NEH)

Scope:

To expand the role of the humanities in undergraduate education at two- and four-year institutions by encouraging partnerships between humanities faculty and their counterparts in other areas of study.

Deadline:

September 7, 2023.

Funds:

\$1.5 million total for up to 20 awards of up to \$150,000.

Areas:

Funding supports the planning or implementation of curricular projects connecting the humanities to the physical and natural sciences; pre-service or professional programs, including law and business; computer science, data science, and other technology-driven fields; or other non-humanities departments or schools. Projects must incorporate the approaches and learning activities of both the humanities and the non-humanities disciplines involved

Media Projects (NEH)

Scope:

To support collaboration between media producers and scholars to develop humanities content and to prepare documentary films, radio, and podcasts that engage public audiences with humanities ideas in creative and appealing ways.

Deadline:

August 9, 2023.

Funds:

Up to \$75,000 for Development awards; \$700,000 for Production awards; and \$1 million for the Chairman's Special Awards. Twelve awards are expected.

Areas:

All projects must be grounded in humanities scholarship. Media Projects awards are made at two levels: Development and Production. Development awards should result in a script (for documentary films and television programs) or detailed treatment(s) (for radio programs and podcasts); and Production awards should result in the production and distribution of radio, podcast, television, and long-form documentary film projects.

<u>Public Humanities Projects</u> (NEH)

Scope:

Announcement to support projects that bring the ideas and insights of the humanities to life for general audiences through in-person programming.

Deadline:

August 9, 2023.

Funds:

Maximimum award amount of \$75,000.

Areas:

Projects must engage humanities scholarship to analyze significant themes in disciplines such as history, literature, ethics and art history. The program supports projects in three categories: (Exhibitions, Historic Places, and Humanities Discussions), and at two funding levels (Planning and Implementation). Proposed projects may include complementary components: for example, a museum exhibition might be accompanied by a website or mobile app. Project topics may be international, national, regional, or local in focus, but locally focused projects should address topics that are of regional or national relevance by drawing connections to broad themes or historical questions. Projects that don't address issues of concern to wider regional or national audiences might consider local sources of funding, such as their state humanities councils.

Our Town (NEA)

Scope:

To support projects that integrate arts, culture, and design activities into efforts that strengthen communities over the long term.

Deadline:

August 3, 2023.

Funds:

Grant amounts must be requested at one of the following levels: \$25,000, \$50,000, \$75,000, \$100,000, \$150,000 or \$200,000. All grants require a nonfederal match of at least 1 to 1.

Areas:

It encourages applications for artistically excellent projects that: bring new attention to or elevate key community assets and issues, voices of residents, local history or cultural infrastructure; inject new or additional energy, resources, activity, people or enthusiasm into a place, community issue or local economy; envision new possibilities for a community or place—a new future, a new way of overcoming a challenge or approaching problem-solving; and connect communities, people, places and economic opportunity via physical spaces or new relationships.

Education Innovation and Research Program—Early-Phase Grants (ED)

Scope:

Announcement to create, develop, implement, replicate, or take to scale entrepreneurial, evidence-based, field-initiated innovations to improve student achievement and attainment for high-need students and to rigorously evaluate such innovations.

Deadline:

August 1, 2023.

Funds:

\$273 million for up to 17 awards of up to \$4 million.

Areas:

Early-phase grants must demonstrate a rationale. Funding supports the development, implementation, and feasibility testing of a program, which prior research suggests has promise, for the purpose of determining whether the program can successfully improve student achievement and attainment for high-need students. Early-phase grants are not intended simply to expand established practices or address needs that are unique to one context. Rather, the goal is to determine whether and in what ways relatively new practices can improve student achievement and attainment for high-need students.

American Latino Museum Internship and Fellowship Initiative (IMLS)

Scope:

Announcement to provide opportunities for internships and fellowships at American Latino museums for students enrolled in institutions of higher education, including Hispanic-serving institutions.

Deadline:

August 7, 2023.

Funds:

\$2 million total for up to 15 awards ranging from \$100,000 to \$750,000.

Areas:

The initiative will nurture students carrying out studies relating to American Latino life, art, history, and culture.

<u>Decision, Risk and</u> <u>Management Sciences (NSF)</u>

Scope:

Announcement to support scientific research directed at increasing understanding and effectiveness of decision making by individuals, groups, organizations, and society.

Deadline:

August 18, 2023.

Funds:

Recent awards have ranged from \$24,000 to \$889,000.

Areas:

DRMS supports research with solid foundations in theories and methods of the social and behavioral sciences. This social and behavioral science research should advance knowledge, address fundamental scientific and societal issues, and have strong, broader impacts. DRMS funds disciplinary and interdisciplinary research, doctoral dissertation research improvement grants and conferences in the following areas: judgment and decision making; decision analysis and decision aids; risk analysis, perception, and communication; societal and public-policy decision making; management science and organizational design.

Economics (NSF)

Scope:

Applications for the Economics program to support research designed to improve the understanding of the processes and institutions of the U.S. economy and of the world system.

Deadline:

August 18, 2023.

Funds:

\$220,000 total for up to 110 awards.

Areas:

The program welcomes proposals for individual or multi-investigator research projects, doctoral dissertation improvement awards, conferences, symposia, experimental research, data collection and dissemination, computer equipment and other instrumentation, and research experience for undergraduates. The program places a high priority on interdisciplinary research and supports research in almost every area of economics, including econometrics, economic history, environmental economics, finance, industrial organization, international economics, labor economics, macroeconomics, mathematical economics, and public finance.

Faculty Development in geoSpace Science (NSF)

Scope:

To integrate topics in geospace science, including solar and space physics and space weather research into natural sciences or engineering or related departments at U.S. institutions of higher education (IHE).

Deadline:

September 18, 2023.

Funds:

\$6 million total for up to four awards. Approximately \$3 million for Track 1 and approximately \$3 million for Track 2, over five years.

Areas:

Priorities include, but are not limited to, aeronomy, or research on the mesosphere, thermosphere and ionosphere of the Earth, and the phenomena of ionization, recombination, chemical reaction, photo emission, and the transport of energy and momentum within and between these regions; geospace facilities for research areas that rely upon existing facilities or develop new instrumentation for geospace observations; and magnetospheric physics for research on the magnetosphere, coupling of the magnetosphere with the solar wind, ionosphere and atmosphere; development of ground-based observations and labbased plasma physics, among others.

Infrastructure Capacity for Biological Research (NSF)

Scope:

To support the implementation scaling, or major improvements to research tools, products, and services that advance contemporary biology in any research area supported by the Directorate for Biological Sciences at NSF.

Deadline:

Proposals are accepted at any time.

Funds:

Up to \$18 million total for 40 to 60 awards ranging from \$25,000 to \$1.2 million.

Areas:

The Capacity program focuses on building capacity in research infrastructure that is broadly applicable to a wide range of researchers in three programmatic areas: Cyberinfrastructure, Biological Collections, and Biological Field Stations and Marine Laboratories. This program will also accept proposals for planning activities or workshops to facilitate coordination that may be necessary in building capacity in infrastructure that meets the needs of a research community. Projects are expected to produce quality products, result in important science outcomes that will be achieved by the users of the resource, be openly accessible to a broad scientific and education community, and serve a community of researchers beyond a single research team.

Neurofibromatosis Research Academy—Leadership Award (DOD)

Scope:

Announcement to develop successful, highly productive neurofibromatosis researchers that will conduct research with the aim of lessening the clinical impact of NF1, NF2, and Schwannomatosis.

Deadline:

Pre-applications are due August 11, 2023; applications must be submitted by August 25, 2023.

Funds:

\$2.08 million total for one award.

Areas:

The NFRA is a unique, multi-institutional interactive virtual research academy focused on supporting innovative high-impact research in a collaborative research and career development environment. The project will provide a framework of intensive monitoring and iterative guidance with proposed research, national networking, collaborations, and a peer group for scholars.

Campus Climate Survey (DOJ)

Scope:

To develop a survey instrument regarding postsecondary student experiences with domestic violence, dating violence, sexual assault, sexual harassment, and stalking.

Deadline:

July 25, 2023.

Funds:

\$900,000 total for one award ranging from \$300,000 to \$900,000. The maximum project period is 36 months.

Areas:

Required activities may include but are not limited to program management, communications, necessary meetings, performance reports, and a data management plan.

Mechanisms and Targets at the Intersection of HIV and Substance Use (NIDA)

Scope:

To support research on the discovery and development of novel chemical and biological approaches to prevent and/or treat central nervous system (CNS) complications associated with HIV infection and substance use.

Deadline:

Letters of Intent, July 9, 2023; proposals, August 9, 2023.

Funds:

\$3 million total in FY24 for four to six awards. The maximum project period is five years.

Areas:

Proposed studies could be but are not limited to elucidation of mechanisms by which HIV and host protein expression, interactions, and post-translational protein modifications are modulated by substance use, HIV infection, and antiretroviral therapy application of emerging target and drug discovery technologies to identify targets and pathways amenable to therapeutic intervention; and screening and identification of small molecules or proteins that can be used as modulators of pathways and interactions implicated in HIV-SUD comorbidity, among many others.

Avenir Award Program for Genetics—Epigenetics of Substance Use Disorders (NIDA)

Scope:

Announcement to support early-stage investigators proposing highly innovative studies that open new areas of research for the genetics or epigenetics of addiction.

Deadline:

Letters of Intent are due 30 days prior to the application due date; proposals, September 25, 2023.

Funds:

The number of awards depends on appropriations and the submission of a sufficient number of quality applications. The maximum project period is five years.

Areas:

The award will support those in an early stage of their career who may lack the preliminary data required for an Ro1 grant, but who propose high-impact research and who show promise of being tomorrow's leaders in the field of genetics or epigenetics of substance use disorders.
